The Office of Finance and Administration would like to inform Doane of the following updates.

Externally Funded Projects at Doane University

Doane's current portfolio of sponsored programs includes \$9.75M (24) projects) in awards from federal agencies, small federal and foundation grants, and major donor contributions. Projects range from large multimillion dollar federal grants that span years and support university-wide efforts to small, short-term projects that impact select staff and students.

The Doane sponsored programs staff is here to help faculty, staff, and students identify and secure external funding for approved projects and programs. Faculty, staff, and students are not authorized to submit proposals on behalf of the institution and must follow institutional procedures for preparing and submitting grants, however large or small.

Please reach out to Sarah Zulkoski, the Director of Grants and Foundations Relations, to discuss potential projects, regardless if a funding mechanism has been determined. Please also contact Sarah if another institution would like to involve Doane faculty, staff, or students in their project. Sponsored program staff will assist with project and proposal development, including the preparation of project budgets, and will ensure proposal submissions follow all university, federal, and funding agency guidelines.

Doane sponsored programs staff: These individuals provide pre-award and post-award services and compliance and regulatory oversight. They support the pursuit and management of sponsored projects on all Doane campuses.
